HOW TO GET STARTED:

1. Follow the directions to **create an account** or Login to **HorseShowsOnline** by clicking the "Member Services" button in the main menu.
2. Once you are logged in, **click the "My Horses, People, Shows"** button in the member menu.
3. At the People, Horses, Shows Page, add any new people and horses to your account as required on the appropriate tab (i.e., *My People, My Horses*). People and horses are saved with your account. **Once you have those records in your account you can use them at every show you enter.**
4. Click the "Enter Show" button to select the show you want to enter and follow the steps in the online entry wizard.

STEPS TO ENTER A SHOW:

Select the show you want to enter from my "My People, Horses, Shows" page on the "My Show Entries" tab, or find the show you want to enter in the show selector and click the **Online Entry** icon. This will start the online entry wizard. **IMPORTANT: Make sure you have already created the horses and people in your member account.**

The online entry wizard will guide you through the steps to complete the entry form. The basic steps in the wizard are:

1. Select the horse, people, and riders for your entry.
2. Select the classes each rider is entered in.
3. Select the quantity for stalls and other fees.
4. Confirm your selections.
5. Checkout and submit the show entry.

The final step generates the completed entry form and submits your entry for review and acceptance. ***If the show requires a payment at entry time, you will be prompted for your credit card information.***

TIPS:

You can cancel the entry part way through the wizard and resume the entry later. For example, if you need to add more people to your account, or you just want to come back and complete the entry later. Unfinished entry forms are listed in your "My Entries" tab and will allow you to edit the entry.

People and horses you create in your account are saved permanently and can be used in other shows you enter. You only need to add people and horses once and then they can be reused.

All exhibitors will be required to open show accounts at the show office by depositing an open check, cash, or have a credit card on file.

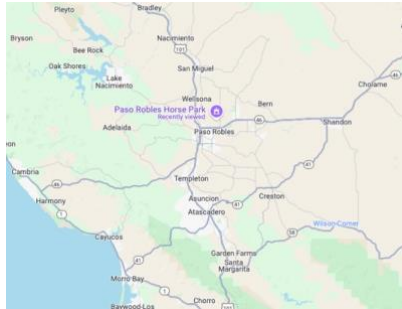

DIRECTIONS: From Interstate 5 take Exit 278 for Hwy 46 Paso Robles. Turn right on Airport Road, then left on Dry Creek Road, and then left on Hughes Parkway.

From Hwy 101 take Exit 231 for Hwy 46 Fresno/Bakersfield. Turn left on Airport Road, then left on Dry Creek Road, and then left on Hughes Parkway.

No smoking anywhere on the property. Smoking is never permitted in the stabling areas or office. Dogs must be leashed at all times, or securely tied in a safe place away from horses, people, and other dogs.

Office hours are 8:00 am – 5:00 pm Monday through Friday.

In Case of Emergency: Please immediately notify a Paso Robles Horse Park employee. If the office is closed or no one is available, summon help by dialing 911.

Show Rules And Regulations

1. Every class offered herein which is covered by the rules and specifications of the current USEF rule book will be conducted and judged in accordance therewith. *The Silicon Valley Horse Show is a USEF Competition Lite show.*
2. ***Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.***
3. The Rated Sections of this Competition are eligible for half points in the USEF Federation and USEF/ ZONE 10 Horse of the Year Awards Program.
4. The Horse Show Executive Committee reserves the right to interpret all questions and conditions in regard to, or arising out of, or incident to, the show without claims for damages or recourse of any kind. Any questions not covered in these rules and regulations shall be decided by the Horse Show Executive Committee, their decision is final. The Horse Show Executive Committee to include the Horse Show Manager, USEF Steward, and an Attorney.
5. All entries are accepted with the understanding that the Silicon Valley Horse Show and the Paso Robles Horse Park will not be held responsible for any loss, damage or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned to him, his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the Silicon Valley Horse Show and the Paso Robles Horse Park against any and all loss, damage and liability thus occasioned including but not limited to any and all legal costs, including attorney fees, which may be incurred as a result thereof. The submitting of an entry form shall constitute an acceptance by each person of the provisions herein set forth.

6. All owners and exhibitors will be held responsible for any damage incurred by them or their agents to barns or the Paso Robles Horse Park properties and will be billed accordingly.
7. The Silicon Valley Horse Show reserves the right to refuse or accept conditionally, or to cancel any entries, and cancel award prizes, without claim for damages.
8. **The Silicon Valley Horse Show reserves the right to cancel and/or combine classes with insufficient entries and will combine classes specifically as prescribed in the class specifications.**
9. The Silicon Valley Horse Show reserves the privilege of substituting or changing judges if it becomes necessary. The judges' decisions in the show ring are their own responsibility and the Show Committee accepts no responsibility for these decisions.
10. Entries will be considered acceptable if they are: 1) Properly signed, by the owner, trainer and rider, and, in the case of a minor, signed by a parent or guardian. 2) Made on an entry blank provided by the Show. 3) Showing correct mailing address of owner. 4) ACCOMPANIED BY A MINIMUM PAYMENT THAT COVERS THE STALLS AND HORSE FEES. PAYMENT MAY BE MADE BY CHECK OR CREDIT CARD AUTHORIZATION. (Visa, Master Card, Discover - 4% fee) 5) ACCOMPANIED BY CURRENT REGISTRATION PAPERS AND COPIES OF ALL USEF MEMBERSHIP AND ALL BREED MEMBERSHIP CARDS, AS APPLICABLE.
11. Entries close April 26, 2026. **Enter online at www.horseshowsonline.com or send to Lori Nelson 956 Hill Rd., Paris, KY 40631. Do not mail after April 26.** Post entries may be accepted with penalty at the show office. Stall Reservations must be made by the close of entries, April 26, 2026. Reserve stall by texting Lori Nelson at 859-457-0841 or email at loriluvshorses@yahoo.com
12. Stabling. Stalls will not be available until 10:00 a.m. MONDAY, May 4, 2026. Stalls must be vacated by 6:00 p.m., SUNDAY, May 10, 2026. An additional night through May 11, 2026 can be prearranged and a \$50/stall charge will apply.
13. Cancellation or Substitution of Entries. Exhibitors canceling their entries for any reason other than illness of horse or rider after the official entry closing date shall forfeit entry and stall fees. In case of illness, a Veterinarian or Doctor Certificate is required before close of show, whereby entry fee and stall fee will be refunded, less a \$40.00 office fee. Where exhibitors or trainers wish to make a change in entries in any class, they are required to follow the procedure of scratching the existing entry and making a new entry with the Show Secretary's office. Such changes shall be treated as post entries and charged the post entry fee. In the event of the sale or injury to a horse (Veterinarian's Certificate required), exhibitors may post enter another horse in the same class at the rate of \$5.00 per class.
14. Changes. Care should be taken to enter animal in its proper class. Sex and age of horses must be correctly stated, as well as the correct date of birth of Junior

riders. Exhibitors are responsible for their errors and those of their agents in making out entry blanks. Any changes will be charged for at the rate of \$10 per class. In all classes, the description on the entry blank must fully identify horses. The word "entry" will not be accepted.

15. Scratches and Rider Changes. All scratches and rider changes **MUST** be made in the Horse Show Office **no later than 2 hours prior to start of Performance**.
16. Championship Entries. To be eligible, horses must qualify in class as noted in list of classes. No Post Entry Fee will be charged on any Championship/Stake Class.
17. USEF Amateur Certification. Every person who has reached his 18th birthday and competes in classes for amateurs under USEF rules must possess current amateur certification issued by the Federation. This certification must be available for inspection or the competitor must have lodged with the Show Secretary, at least one hour prior to such class, an application for such certification provided by the Federation.
18. RV Facilities. Overnight facilities with hookups are available at the Paso Robles Horse Park for \$350 Monday-Sunday plus applicable taxes. A late departure fee (\$1,500) is assessed by the Horse Park after 10:00 PM on Sunday. To reserve a space, contact Helen Roy at 415-420-3216.
19. Dogs, or other pets, must be leashed and under direct control of their owners, or securely tied or crated in a safe place.
20. Hay and shavings will be available for purchase from the horse show and will be delivered to the stables. Additional orders may be placed through the horse show office during the show. Exhibitors may bring in their own hay or shavings before the show but may not arrange their own commercial delivery to the show grounds. To place orders for hay or shavings contact Lori Nelson at 859-457-0841 or email at loriluvshorses@yahoo.com.
21. Food and beverages will be available during horse show performances, both at the horse show arena or from food vendors.
22. QUESTIONS, DISPUTES and PROTESTS. All protests and questions not covered by these rules shall be decided and interpreted by the Competition Committee, whose decision shall be final. Disputes should be presented to the USEF Steward.
23. There will be a penalty of \$50.00 if a check is refused by the bank for any reason. No checks will be processed through the bank a second time, and must be covered by a money order, cashier's check or cash, in addition to the penalty.
24. No competition numbers will be released by the Show Office until all entry forms are complete, all necessary registration papers and measurement cards have been seen, and payment in full has been received by the Show Office. A

SIGNED OPEN CHECK, OR CREDIT CARD MUST BE LEFT WITH THE SHOW OFFICE FOR FEES INCURRED DURING THE SHOW.

25. The winner of a leg on a Challenge Trophy or a Perpetual Trophy is entitled to possession of the trophy for a period of 10 months from date of winning. The winner is responsible for protection and care of the trophy while in his/her possession. The winner will return the trophy engraved and polished. A receipt must be signed by the winner prior to taking possession of the trophy. Two months prior to the next show, the trophy must be returned.
26. Prize money will be paid by check and mailed within 30 days, provided there are no outstanding balances on the trainer's accounts.
27. Arena footing is GGT Sand and properly maintained to the specifications of the Saddlebred and Morgan Division. Arena is 120' x 250'. The warm-up arena footing is GGT Sand and is 140' x 230'. Stalls are 12' x 12' with permanent stall doors.
28. **MOTORIZED VEHICLES** — Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. **The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation.** Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B.
